ABOUT MEMBERSHIP

Individual taxpayers (income tax) can agree to their contribution being counted as Gift Aid, which allows Rural Action Yorkshire to reclaim tax. Please ask for further information.

Joining Rural Action Yorkshire automatically entitles a village hall or community building to membership of the Rural Community Buildings Association, at no extra cost. Association benefits include a separate mailing and invitations to special meetings, which focus on issues relating to funding and managing a community building.

MEMBERSHIP AND VOTING

Membership subscription is for one year from the date of receipt of your first subscription. This will become your anniversary date, on which, subsequent membership fees will be due. All members are invited to the Annual General Meeting. Group members will be asked to nominate a representative from within their organisation to vote on their behalf on matters raised at the AGM. Individual members may vote in their own right. Representatives and individual members may be nominated for election to the Board of Trustees. Any member may put a name forward for consideration, by notifying the Chief Executive. New members with skills to offer in helping to shape the direction of Rural Action Yorkshire, are particularly welcome.
